President's Message

Dear Fellow Artists,

Who knows that you are an artist?

You have put many hours (or years) into creating some great artwork. You have created something pleasing and beautiful. You feel proud of your work and you want to share it and maybe sell it. Sure, you can join OAA or similar area art groups to participate in their art shows and display your work. You send out the post cards to family and friends and hope they will come to the show. But everyday you have transactions with people who don't know that you are an artist, like your bank, your medical professionals, your church, your neighbors, your favorite restaurant.

Have you had the experience of sitting in the doctors waiting room looking at faded, dreadful Walmart or Ikea prints, vintage Goodwill 1970, and thought to yourself "This artwork is awful?" Or going into your bank and seeing the glib, corporate advertising? Each time I see such poor taste decoration I mention to the official "Your office needs some good artwork." Usually the official has to stop and think since no one ever said that. Then I add, " I'm an artist and can help." I give them my business card with website and see what sort of discussion develops. This technique has brought many opportunities to display and sell my artwork. Sometimes I'll offer to put some artwork in their waiting room and change it every two months at no cost. If it sells, they get a commission. The point is each artist is responsible to push the envelope and promote their artwork. You have made beautiful artwork and you are proud of it. Let people know that you are an artist and your work can help their business grow. Customers like to see beauty and artwork that takes them to a different place. Customers are more willing to spend when they feel good about the decorations. *OAA Coming Events:*

A Visit to Aix-en-Provence

A visit to the city of Aix-en-Provence in France, home of the renowned painter, Paul Cezanne, can provide the occasion for a tour that follows the path of his life. The school he attended as a teen is still standing. This

is where he befriended a classmate who would become a famous French writer, Emile Zola. Later in his life, at the urging of his father and contrary to his own wishes, Cezanne would study law at the University of Aix, although he continued to take drawing lessons. His friend, Zola, would encourage Cezanne's decision to abandon his legal studies and go to Paris to study art.

his initial fortune still stands on the Cours Mirabeau in the center of the city. His father used the wealth he accumulated to start a bank, the Banqe Cezanne et Cabissol. His father's wish that his son work for the bank was a source of tension between them for much of Cezanne's life. Ultimately, they reconciled. Cezanne's father supported Cezanne in his career as a painter all his life and left him a large

fortune. A portrait of his father by Cezanne can be seen in the National Gallery of Art in Washington, D.C. This painting was Cezanne's one and only successful submission to the official Paris Salon.

Cezanne put great stock in northern light because it does not change during the course of the day. One of his studios in the center of the city had northern exposure through a huge window that Cezanne had installed. Finally he built a large structure with a studio on an upper floor far outside the city, although the city now surrounds it on all sides. The Atelier Paul Cezanne still stands and the studio on the upper floor, with northern exposure, contains many of the props for his paintings that were left at the end of Cezanne's life. It is open to the public.

Cezanne is said to have painted almost 1,000 pictures and to have destroyed 1,000 more. He was a notorious perfectionist and destroyed paintings if he could not perfect them. Fragments of destroyed paintings have been discovered on the grounds of the Atelier. Cezanne is buried in Aix in the Saint-Pierre cemetery.

Picasso famously referred to Cézanne as "the father of us all" and claimed him as "my one and only master." He is understood to have been a seminal influence for cubism and other strands of 20th century art. The Musee d'Orsay in Paris probably has the largest collection of his works. Chateau Noir, Boy in a Red Waistcoat and others can be seen at the National Gallery in Washington, D.C.

Jennifer Rutherford

OAA Member and multifaceted visual artist, Jennifer Rutherford, is our speaker. She is also a performing artist and singer with a Master of Music Degree from Canada in Voice Opera. Her artwork is inspired by her love of American impressionist John Singer Sargent.

Still life, abstracts and fantasy paintings round out Jennifer's body of work. She began painting in 2000, studying with many well-known local artists. Jennifer was tapped to use her skills for graphic design for three years in a publishing position in Reston/Herndon VA.

Jennifer shares her love of music and art with inner city kids, co-founding and teaching a Monday night arts program in Anacostia for 11 years. Her awardwinning work is hung abroad in Edmonton, Vancouver, and Toronto, Canada; in Australia; and in the Eastern United States

The Opera and Visual Arts

Jennifer Writes:

"For as long as I can remember I have sung and I have acted. It was my chosen vocation over many years even to the present. Opera was my medium, an artistic vehicle capable of transporting an audience to another place and era through classical sound and visual effect.

Now as a painter I am intrigued to give insight into both the opera character and the actor's underlying humanity, surreptitiously peering behind the mask. I take photographs of my subjects posed in evocative lighting, seeking to capture a single, fleeting moment of commonality, as the actor blends into and assumes character in period costume. What emotion can be glimpsed through the analysis of a characterful expression? What enigmatic puzzle lives side-by-side in the sitter's reality and the character's story? What is more real, the person or the persona? What I seek to impart is a subtle, emotional undertone common to both the fictional narrative and the actor. Through the juxtaposition of humanity, role, and paint on canvas, I celebrate these two subjects' intertwined existence.

My favorite opera I am going to say is Carmen, but it's hard to choose because they are all so different. I love La Traviata, and Mozart's operas. I have performed three Mozart roles, Despina in <u>Cosi Fan Tutte</u>, which was a lot of fun, I did Silverpeal in <u>The Impressario</u>, and The First Lady in <u>Magic Flute</u>, plus many other opera excerpts and scenes. "

Committee Duties

Jury Committee: Prepare and send out the juror's contract, confirmation letter of acceptance, and provide juror with pertinent info regarding show guidelines/schedule. Ensure that the juror's statement is received. On jury day, prepare the room for art submittal, registration, labeling, and arranging art for juror's review/awards. Check artwork as received to assure proper labeling/framing. Assure that artist forms and entry fees are complete. Record artwork data for use in program.

Hanging/Take Down Committee: Ensure all documents required for show have been submitted and are complete. Hang the art with title cards. Check bin work. Assure all artists sign out their work at take down. Art will be removed on Tuesday, November 12, 10:30-11 a.m. Assure that all paintings have been picked up.

Refreshment Committee: Manage sign-up list of volunteers. Ensure that all refreshment needs are arranged and sufficient for the reception. Monitor tables and refill platters. Clean-up after the reception.

Program Committee: Prepare the show program for distribution.

Awards Committee: Prepare and place in labeled envelopes the certificates and award checks for recipients. Order award ribbons.

Publicity Committee:

Prepare press release with image and send to publishing agents/contacts to comply with their schedules Create/distribute show postcards and flyers using image of prior year's "Best in Show."

Show Details

Jury Day

Bring your artwork entries for jurying to the Community Room/Buffington Bldg. in Olney on Monday. September 9, 3-3:30 p.m. Pick up all art after jurying the same day, 5:30-6 p.m.. You may bring up to 3 framed entries for jurying, with a \$15 entry fee . Registration forms and releases are also due at this time. 50 pieces of art will be juried into the show.

Presentation/Framing

Remember that in addition to technique and originality, our juror will be looking at your finished presentation. Although framing is influenced by personal preference, there are some general guidelines for framing art to be presented in a show: cleanliness (clean mats & glass), mats should be neutral, i.e., white, off-white, cream. Frames should not overpower the art and be in good condition with securely attached hanging wire.

Label Your Artwork

Each piece must be identified on the back with your name, title of art, medium, your address, phone number and email.

Hanging

On September 10, bring art juried into the show to Kentlands Mansion.

Inside or Outside? By Penny Kritt

There are no images in this article. It's purpose is to get you thinking, unencumbered by a particular starting point.

The best lesson on composition I ever got was at a five-day workshop by Carla O'Connor. There were 25 advanced artists there. The exercises were difficult. But we pretty much breezed through them and we were all feeling pretty sure of ourselves.

Then came the "list" exercise. She gave us a list of items which all had to be in the large sketch on a big newsprint pad. We had to include a bed, pillow, a rug, scissors and about 10 other things that you could often find in a bedroom. We had about 90 minutes to put together a sketch using a black marker.

Then we lined up our easels in a row for the critique. It was immediately clear what her point was, and we had all failed miserably! All of them looked alike! There were a few differences in the placement of the items, but each was done as if the viewer was standing in the doorway of a bedroom. We got the items in the composition, but none of us took a novel approach to the task.

Luckily, we didn't have time to wallow in humiliation because now we had an hour to come up with a unique approach. This time, wow, what a difference. One artist did the scene from the viewpoint of a peeping tom who was outside staring through the window. Another included all the items – in the window of a pawn shop. A third artist used large scissors as a sign outside a barbershop and the other items were inside the building. Now we had 25 unique compositions!

Her point was that one should always consider a different approach, especially to what seems to be a typical composition.

At that point, Carla told us that as well as being an award-winning artist, she often judged the biggest art competitions. As she anticipated, we all immediately begged to learn the secrets that would get our future work accepted into shows! She graciously agreed and we settled in to let the magic wash over us. Her first comment was that even the best artists are never guaranteed to get into any show! The judges do not see any signatures, although they often recognize a particular style. A related problem is to take a recognizable approach to a familiar genre.

If you've ever seen an art show with a spring flower theme, there are always submissions of floral still life paintings with the flowers in a woven basket and maybe a piece of silver on a lace doily all set on a polished wood surface. These are often masterpieces of technique. The silver gleams, the mahogany or rosewood surface is opulent, and you can almost smell the flowers. The good folks who hung the show put this next to four other paintings that were basically the same "master's thesis" of painting textures. And in that close context, they all were suddenly boring.

When you design your next composition, even if you'll never enter an art show, think about a different approach. Google images for Tuscany, and you'll see fields of mauve and ochre and sparkling water that is teal and beige. No more boring green landscapes! Doing a still life? Think about interesting related items that tell a story. Get out all your tools and put them on a cardboard box that's draped in an oily rag. Or do a portrait of the broken doll (or action figure!) that you've kept all these years.

One of the best compliments an artist can get is to see someone stopped in front of a painting, just standing there for a long time. Maybe that viewer has also been you. How did the artist get that effect? Look how the brush strokes show the hair or fur or veins in a leaf. See the dead mouse that the cat brought home to share with the family.

Now you know how to think outside the box!
