#### Jury Day

Artwork entries will be juried on Saturday October 11th, 2014 at 10am. You may bring1-3 framed entries for jurying, with a \$6.00 fee per entry. Registration forms and releases (found at the end of this newsletter) are also due at this time. Pickup after jurying is the same day, 2:30-3:00 p.m.

Our judge this year is the masterful artist and art teacher Glen Kessler. Glen has an MFA in Painting from the New York Academy of Art, and a BFA in Painting from the Maryland Institute College of Art. He's taught at the Yellow Barn Studio since 2008 and MICA since 2001. His paintings have exhibited in dozens of solo and group exhibitions and he's received numerous awards. Glen is a popular and dynamic instructor who believes anyone is capable of achieving a superior level of skill and artistic understanding with the proper guidance. #### Labels

In addition to the labels you will fill out on the registration form for each piece you enter, it is recommended that you attach your own label as well:

#### **Presentation and Framing**

Remember, in addition to technique and originality our judge will be looking at your finished presentation.

Although framing is influenced by personal preferences there are some general guidelines for framing art to be presented in a show:

- Cleanliness clean mats and glass, no smudges, dirt or pet hairs.
- Mats should be neutral- white, off white or cream
- Frames try not to overpower your art. Avoid using scratched or battered frames.
- Hanging wire make sure it is securely attached.

#### Hanging the Show

Bring entries juried into the show to Woodlawn on Friday October 31, 2014, between 12 noon and 12:30 p.m. The Hanging/Take Down Committee will receive the entries and hang them for display. Any matted artwork for the bins (16 x 20 or smaller) should be dropped off as well. All art for the bins needs to be clearly labeled, matted and backed, and shrink-wrapped or in plastic envelopes.

#### The Show

The show opens on Saturday November 1 and extends through Sunday November 9th. Each day during the run we will need members to host the show, greet visitors, and handle sales of bin work.

#### Reception

The Artist's reception is on Sunday November 2nd, 2014 from 12 noon - 3:00 p.m. Glen Kessler will be available to present awards at 2:00, as well as choose winners for our door prizes. The Best in Show award is being generously donated by Sharon Longley. There will also be three juror's awards and six honorable mentions.

#### 1. Jurying Committee:

Prepare and send out the juror's contract, confirmation letter of acceptance, and provide juror with pertinent information regarding Woodlawn Show guidelines and schedule. On Jurying day, prepare the jury room to facilitate OAA group art submittal, registration, labeling and arranging the artwork for juror's review and awards. Ensure that the juror's statement is submitted and prepare the final program list for distribution and coordination with other committees. (Refer to complete Woodlawn Guidelines for details).

#### 2. Publicity Committee:

Prepare press release with image and send to publishing agents/ contacts to comply with their schedules. Create flyers advertising the show for final distribution. Ensure that the banners and other generic signs are hung and located at most visible locations at Manor area. (Refer to complete Woodlawn Guidelines for details)

#### 3. Hosting Committee:

Manage the sign-up sheets for hosting volunteers, prepare a final hosting schedule and distribute copies to all volunteers with their schedules and contact information. Ensure that the program, guest book, comment book, are displayed at their designated table space during the show; hosting book and copies of committees' guidelines, sales receipt book, calculator, pens are at the entry table. (Refer to complete Woodlawn Guidelines for details).

#### 4. Awards Committee:

Using the list of award winners provided by the Jurying Committee, prepare and place in labeled brown envelopes the certificates and award checks of recipients. Order award ribbons. (Refer to complete Woodlawn Guidelines for details).

#### 5. Invitations and Brochure Committee:

Create postcards with pertinent information about the show using image of previous "Best in Show" winner. Manage the distribution of flyers, brochures/pamphlets, bookmarks. (Refer to complete Wood-

lawn Guidelines for details).

#### <u>6. Hanging/Take Down Commit-</u> tee:

Ensure all documents required for the show has been submitted and appropriately filled in. Take pictures of all walls to record museum's art placements, so arts can be replaced back at the end of the show. Responsible for hanging all OAA arts, with numbers identifying them according to the process set by the committee. Bin work is to be checked separately. All artists to sign out their work at take down, ensure that Manor is cleaned up and all OAA belongings are collected and stored in attic/ OAA storage boxes. (Refer to complete Woodlawn Guidelines for details).

#### **Refreshment Committee:**

Manage the sign-up list for volunteers. Ensure that all reception/ refreshment needs are complete and sufficient for the reception. Monitor table needs, refill platters, and ensure that reception is keep neat. Members to help with general clean up after the reception, with all left over food stored in the refrigerator. At the final end of the show, refrigerator must be emptied. (Refer to complete Woodlawn Guidelines for details).
