OAA will meet once again in person or via Zoom at Salem United Methodist Church in the Community Hall at 12 High Street (Georgia Avenue) in Brookeville, MD at 7 p.m. on March 14, 2022. Look for an invitation to the Zoom meeting in your email.

Our March guest speaker will be printmaker, **Carol Moore**. She will be discussing various printmaking techniques and show us how she has applied them in her work.

After working for many years as a graphic designer and a mural painter Carol chose to redirect her creative energies into printmaking. Since 2010 Carol has been exploring the endless possibilities offered through printmaking techniques!

Moore has exhibited locally at BlackRock Center for the Arts, Strathmore Mansion, Gaithersburg Arts Barn, Touchstone Gallery in Washington DC, Artist's on Market, and Glenview Mansion. She has also participated in many juried exhibitions such as Strathmore's "What's On your Mind" and "Women Chef's: Artists in The Kitchen", MFA Art on Paper, Washington Printmakers National Small Works, MFA at College Park, and Delta National Small Works at the Bradbury Art Museum in Arkansas where she has several works in their permanent collection.

Carol Moore offers a selection of original hand-pulled Intaglio and Lithographic prints that strive to capture the essence of the human experience using nature as her language. In her journey exploring the natural world, she has found that the human spirit is unequivocally linked. Many of Moore's prints are hand-colored using a technique that she has developed that pushes the color behind the ink creating cohesive and intimate details.

**La Galeria at Ranazul** is located at 8171 Maple Lawn Boulevard, Suite 170, Fulton, MD 20759. (301/498-9666) You may visit www.ranazul.us to see more information on the Gallery as well as directions. The gallery will accommodate 20 to 30 pieces depending upon size.

The dates for our exhibit are as follows:

Sunday, May 1, 9:00 a.m. Artists deliver work and hang the show.

Sunday, May 15, 3:00 - 4:00 p.m. Ranazul-sponsored champagne reception;

Sunday, May 29, 9:00 a.m. Take down the show.

Each artist is responsible for delivering and picking up her or his own work.

You may submit two (2) pieces of art for consideration; however, only **one piece will be accepted.** Applications will be accepted on a first come/first serve basis by email or U.S. Mail. If space allows, we will choose a second piece from the existing applications -- again on a first come/first serve basis. Please include a photo of each entry with your application or a jpeg image if applying via email. Size range: 11 x 14" to 20 x 24", **framed** -- basically no smaller than 154 sq. in. and no larger than 480 sq. in. There is some room for variation in height but not width. You can check with the Howard Clark if you have questions regarding this. **NOTE: Dues must be current in order to participate in any way.** 

All artists must fill out the "**RANAZUL** 'LaGaleria' ART GALLERY AGREEMENT" and submit it with their entry. If your piece is sold, IRS requires you to provide your social security number to the gallery manager. All sales are handled through Ranazul, and they take a 20% commission. OAA takes no commission, and there is no fee to enter.

The artist is responsible for the transport of works to and from the gallery.

3. For reasons of safety and security, delivery and pick-up times will be set to avoid conflicts during operating hours.

4. The Artist(s) shall defend, indemnify, and hold RANAZUL, RANAZUL, LLC, its officers, employees, and agents harmless from and against any and all liability, loss, expense (including reasonable attorney's fees), or claims for injury or damages arising out of the performance of this Agreement but only in proportion to and to the extent such liability, loss, expense, attorney's fee, or claims for injury or damages are caused by or result from the negligent or intentional acts or omissions of RANAZUL, its officers, employees or agents.

5. Either a social security number or federal identification number are required for the sale of artwork.

8. The Artist(s) may not change the sale price of a piece during the period of time that the piece is in the gallery.

9. The Gallery will not furnish the Artist's contact information to interested persons, but will forward to the Artist(s) the contact information of any person interested in the Artist's work. If any referral by the Gallery to Artist(s) results in the sale of the Artist's work to a client, Artist(s) agree to pay Gallery a 10% finders fee on the initial sale.

10. All works, including those that are sold, must remain on exhibit through the end of the last day of the show. Sales will be processed at the end of the show. The Artist(s) will receive a check within two weeks.

11. The Gallery will email an exhibition announcement. The Artist(s) can provide a photograph and an artist's statement at least two weeks prior to the opening of the show. An artist's biography may also be helpful in publicizing the show. The Gallery will send press releases to regional newspapers.

12. The exhibition announcement will be emailed to the Gallery's mailing list. If the artist(s) provides an email list, the gallery will also email announcements to the artist's email list.

13. La Galería also has an Art Gallery Online internet page where the shows are publicized. The artist's statement, biographical information, and, at the very least, low resolution images of the installation will be presented. At the artist's discretion, the Art Gallery Online may also display low resolution images as examples of individual works by the artist.

 The gallery will provide a one-hour champagne reception for the Artist(s). Time and date of the reception at the discretion of the Gallery.

15. An exhibit may be terminated and/or individual works may be withdrawn from display at any time at the discretion of the Gallery. Gallery reserves the right to exercise discretion with respect to public displays of art.

# **Regarding the Election of OAA Officers**

The OAA constitution dictates that elections for officers are to be held at the January business meeting of OAA in odd years, but this did not happen in January of 2021. The lack of meetings due to the pandemic led this fact to be overlooked. At the December OAA board meeting, the situation regarding elections of officers was debated. A couple of factors complicated the possibility of holding elections in January of 2022... 1) the constitution states it should be done in odd years, 2) 30-day notice must be given, 3) we are still only beginning to meet in person. With these complicating factors, the OAA board has decided to keep in step with the odd year elections and aim to present a slate of officers for elections in January of 2023. All officers are volunteers serving the membership of OAA. Your board always welcomes input from you and welcomes anyone who wishes to participate in board meetings which are held on the second Mondays of the months opposite of the general meetings.

#### Excerpted from the OAA Constitution

#### Article V -- NOMINATIONS AND ELECTIONS

**Section 1**: The residing board shall comprise the nominating committee and will accept volunteers for the positions which will become vacant. In the event no volunteers are available, the board will nominate members in good standing 30 days prior to the elections.

**Section 2**: If any elected office becomes vacant, the executive board shall choose and vote on a member to fill the vacancy until the next election.

**Section 3**: Officers shall be elected biannually (in odd years) at the January meeting by vote of a majority of members present and voting. Officers so elected shall assume duties at the end of the meeting and shall serve for two years.
