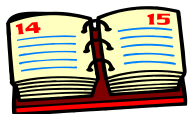

**Artist Statement:** From Paleolithic to present, art preserves a moment that speaks directly to us about the artists’ experience of life. It is my hope that my work speaks to others about our common experiences—appreciating beautiful trees and vivid skies, communicating with other living things, feeling the exhilarating cool of an early fall breeze or the exuberance of spring flowers—fleeting miracles that fill and enrich each of us. This is truly the common ground where we all celebrate beauty and sing the song of life.

**Auto Biography:** I am a native of New Orleans, LA, but have lived in the suburbs of Washington, DC since 1967 when my family moved. I graduated from Montgomery Blair H.S. in 1969, and have a degree in art from Montgomery College. I had a satisfying 25 yr career with the AFL-CIO, retired in 2001 and began my journey as a painter. I’ve shown my work and won awards in many shows over the past years. and shown work at the following galleries: The Artists Gallery in Frederick, MD; The Westfield Gallery of the MAA in Wheaton, MD; Gallery B in Bethesda, MD. ## Have Your Artwork Photographed Professionally

### At ARThouse

On the weekend of September 15 and 16, members of the Olney Art Association will have a private opportunity to have their artwork photographed professionally at ARThouse. Cost is \$12 per painting (the normal charge is \$15). Paintings will be dropped off on Sept. 15 between 9:00-11:00am at ARThouse, and picked up the following day between 3:00-5:00pm. Each painting (up to 10 per artist) will be photographed with a 14 MB Canon SLR camera under balanced studio lighting or daylight. The digital images will be adjusted with Photoshop CS and five versions of each image created (see below). The digital images will be copied onto a CD for you to pick up along with the paintings. The work will be done by Susan Murphy and Ben Colombini at ARThouse.

The five versions of each image include the following (all for the price of \$12):

1. the original photograph in TIFF format for you to use if you ever wish to start from scratch
2. the Photoshop adjusted TIFF image in its largest file size, for making giclee' prints
3. an adjusted largest jpeg image, resolution of 300ppi
4. an adjusted medium jpeg image (1800 pixels) for entering juried shows or making 4x6 prints
5. an adjusted small jpeg image (400 pixels) for website or email use

## 2012 ANNUAL OAA JURIED SHOW AGREEMENT

David Epstein, Juror

### RULES OF ELIGIBILITY

Only original works of art are to be submitted. No reproductions or wet canvas will be allowed. Entries must have been completed within the past three years and may not have been exhibited previously in any OAA juried show. All entries in a juried show must be for sale. OAA will take a 20% commission on sales.

Maximum width is 50" and maximum height is 60" including frame. Plexiglas (not glass) is required on matted work 22" x 28" or larger. Each work must have a hanging wire.

All entries must be labeled correctly. For example: a photograph manipulated on a computer to look like a painting, must be labeled "photograph"; a collage or other work created with several different mediums must be labeled as "mixed media".

When accepted into a juried show, members are required to participate in that show and share the job responsibilities required for that show. Member must work a two hour shift as hostess and bring food to the opening reception.

No substitution, exchange, modification, or withdrawal of works is permitted once accepted for a juried exhibition. No personal business cards or portfolio information will be allowed on display at a juried show at any time.
