Woodlawn Show information continued:

BIN WORKS: There will be 2 OAA bins upstairs and 1 downstairs. No individual bins will be allowed. Artists can submit up to 5 two-dimensional works, which must be properly matted and enclosed in shrink wrap or cellophane bags.

COMMISSION ON SOLD WORKS: 20% commission will be taken on all sold works including bin pieces. Artists may enter 3 framed pieces for jurying.



### **May All-Member Meeting Review**

Debra Halprin, award-winning giclee print artist, was the guest speaker at our May meeting. Giclee printing is high-quality reproduction of original paintings using archival inks that are supposed to last at least 100 years. (Author's note: The word *giclee* is descriptive of ink-jet technologies, and is based on the French language word "le gicleur" meaning "nozzle", or more specifically "gicler" meaning "to squirt, spurt, or spray.") Ms. Halprin uses an Epson 9880 printer that will print on almost anything that can be put on a roll and in sizes up to 4' x 100'.

The process is fairly simple—a photograph of a painting is taken using a digital camera or the original painting can be scanned and entered into a computer in a digital format. The image is shown on the computer screen and according to Ms. Halprin, one can easily see the changes that need to be made to the print or the original painting. She uses Adobe Photoshop software to enhance the color and contrast. Once the changes are made, a print is created to guide the artist to the corrections. When the original painting is completed, another photograph is taken to make sure the changes are as desired. Ms. Halprin suggested that when taking a digital photo of a painting, artist should use the RAW setting on their camera to use the most pixels possible.

During her talk, Ms. Halprin showed originals and her enhanced versions of them, making it easy for the viewer to understand. After her talk, she invited the audience to try oil sticks on a faded giclee print. Most of those in attendance were eager to try it and were amazed at the brilliance of the oils over the giclee. **www.halprinart.com** This article submitted by Sally Drew

**HELFUL HINT** SUBMITTED BY SALLY DREW: When participating in a paint-out, where end-ofthe-day matting is required for watercolors, either buy or cut a mat, draw a line on the paper around the inside of the opening, measure 1/4" - 1/2" outside the lines to create a painting area. At the end of

the day, simply attach the watercolor to the mat and slip them both into a plastic sleeve. The painting is ready to be sold!
