OAA Jurying for Woodlawn Show

Our jurying event (directed by Marian MacKerer) went very well and we anticipate a great show at Woodlawn this year. Thanks to all those who helped. We had 109 entries, of which 86 were accepted. Juror, Jordan Bruns, will be at our show to present the awards and critique the paintings. This is a reminder that **every member** is eligible to put their paintings or prints for sale in our bins. You may enter up to (5) five 2-D pieces. These must be properly matted and with foam core backing, and either shrink wrapped or enclosed in a clear bag. Also, be sure and put your information on the back, i.e., artist name, title, medium, and price. **Pieces that do not meet these specifications will not be accepted.** We encourage **everyone** to take advantage of displaying your work in the bins. **The day to deliver the bin pieces as well as the accepted juried pieces will be Friday, November 4th between 12:15 and 1:15pm.** We look forward to seeing you there!

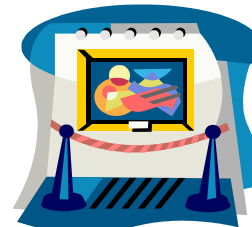

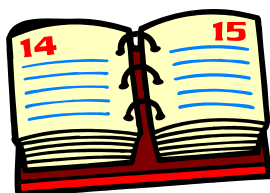

RULES OF ELIGIBILITY

As a member of the Olney Art Association, I do here by agree with and will abide by the rules of eligibility set forth by the OAA when entering a juried show.

1. Only original works of art are to be submitted.
2. No reproductions or wet canvas will be allowed.
3. Entries must have been completed within the past three years and may not have been exhibited previously in any OAA juried show.
4. All entries must be labeled correctly. For example: a photograph manipulated on a computer to look like a painting, must be labeled “photograph”; a collage or other work created with different mediums must be labeled as “mixed media”.
5. All entries in a juried show must be for sale.
6. No substitution, exchange, modification, or withdrawal of works is permitted once accepted for a juried exhibition.
7. No personal business cards or portfolio information will be allowed on display at a juried show at any time.
8. When accepted into a juried show, members are required to participate in that show and share the job responsibilities required for that show.
