Bin Works and Commission on Sold Works


BINS: There will be 2 OAA bins upstairs and 1 downstairs. No individual bins will be allowed. Artists can submit up to (5) 2-D works, which must be properly matted and enclosed in either shrink wrap or cellophane bags.

COMMISSION: 20% commission will be taken on all sold works including bin pieces.

Note: Artists may enter (3) framed pieces for jurying. These pieces must be properly matted, professionally framed and ready to hang. If you

have any questions, please contact one of the board members listed on the back of this newsletter for more information.

Works for jurying must be framed in a professional manner. If not, they will not be accepted.

September Meeting Speaker *Barbara Sweeney*

Be it a gallery, show or art fair, it sometimes seems overwhelming to prepare your work for sale. Barbara will be sharing some ideas on how to cost effectively present your artwork for sale. She will talk about proper proportions for a mat, framing and matting to a standard size. “What are those standard sizes anyway?” How to frame inexpensively yet attractively, and where to get supplies and packaging. She will also offer some tips on marketing yourself and your work.

Barbara is the artist/owner of Art Partners Inc., a framing and art gallery in Clarksville, Maryland. Barbara received her BA in art from Brown University, and her MBA in business and marketing from the University of Virginia. Her artwork includes detailed watercolors, oils, and fine art photography of botanical, landscape and still life subjects. RULES OF ELIGIBILITY

As a member of the Olney Art Association, I do here by agree with and will abide by the rules of eligibility set forth by the OAA when entering a juried show.

1. Only original works of art are to be submitted.
2. No reproductions or wet canvas will be allowed.
3. Entries must have been completed within the past three years and may not have been exhibited previously in any OAA juried show.
4. All entries must be labeled correctly. For example: a photograph manipulated on a computer to look like a painting, must be labeled "photograph"; a collage or other work created with different mediums must be labeled as "mixed media".
5. All entries in a juried show must be for sale.
6. No substitution, exchange, modification, or withdrawal of works is permitted once accepted for a juried exhibition.
7. No personal business cards or portfolio information will be allowed on display at a juried show at any time.
8. When accepted into a juried show, members are required to participate in that show and share the job responsibilities required for that show.
